

# Sustainable Procurement Commitment

This sustainable procurement commitment intends to further Pioneer Natural Resources' (Pioneer) commitment to sustainability by expecting that our suppliers will adhere to our Supplier Code of Conduct and Code of Business Conduct and Ethics, and by:

- Upholding state and federal laws and endorsing frameworks of Corporate Social Responsibility (CSR)
- Utilizing risk mapping and Environmental, Social, and Governance (ESG) assessments of our critical supply base to drive enhanced sustainability practices
- Driving sustainability awareness and innovation with our suppliers, and ensuring sourcing decisions are guided by ESG ratings
- Keeping our commitment to utilizing a diverse supplier base
- Training Supply Chain Management (SCM) staff to understand and communicate focus on sustainability and related policies
- Encouraging suppliers to have a sustainable procurement commitment in place for their own suppliers

## Standards of Corporate Social Responsibility

In accordance with our commitment, we expect our suppliers to aspire to the same standards in their business operations, including but not limited to:

### Labor and Human Rights

Pioneer embraces human rights principles as contained in the Constitution of the United States and similar international human rights principles articulated by the United Nations. Pioneer is a proud member of the United Nations Global Compact. This initiative strives to align companies with universal principles on human rights, labor, environment, and anti-corruption, and takes action that advance societal goals. Pioneer prohibits the use of child labor, forced labor, and promotes fair working conditions, wages, and a safe work environment in accordance with these initiatives.

Pioneer suppliers will comply with the Human Rights Policy and should contact the Legal Department with any questions or concerns regarding human rights. As outlined in our Sustainability Report, Pioneer SCM endeavors to audit suppliers based on our Human Rights Policy, other policies, and practices.
